**AFFIDAVIT OF JOHN HAWKINS
IN OPPOSITION TO
DEFENDANTS' CROSS-MOTION
FOR SUMMARY JUDGMENT**

I, John Hawkins, being first duly sworn, depose and say that:

1. I am a plaintiff in this action and make this affidavit in opposition to
defendants' cross-motion for summary judgment.

2. During the course of my employment, PERB made representations to me that
my pension benefits would be calculated under three, separate alternative formulas (Full
Formula, Money Match, and Pension Plus Annuity) and I would receive benefits based on the


1 formula that produced the highest benefit amount at retirement. PERB also represented that I
2 would be entitled to an annual Cost of Living Adjustment (COLA) of up to 2 percent per year
3 after retirement.

4 3. At the time I was pursuing retirement, PERB also made representations to me
5 that I would receive pension benefits based upon the value of my PERS account at my date of
6 retirement.


7 4. At my date of retirement, the value of my PERS account included 20 percent
8 earnings for the calendar year 1999. Attached as **EXHIBIT 1** to this affidavit and
9 incorporated herein is a true and exact copy of my Statement of Entitlement from PERS
10 including the value of my PERS account at retirement.

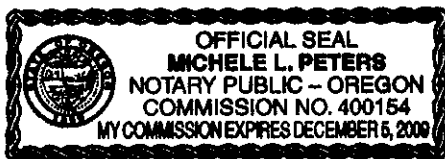
11 5. In making my decision to retire from Linn County, I relied upon the
12 representations made by PERB. Had I known that my retirement allowance would not include
13 20 percent earnings for the calendar year 1999, I would have continued my PERS covered
14 employment.
